Jailer Stephens requested the Special Meeting as he needs the Court to approve hiring his part-time transportation officers so they can attend training. Jailer Stephens told the Court that Marie Suter is the only part-time transportation officer currently working that is interested in staying and working with him. Jailer Stephens wants to have his own policies for his staff. County Attorney, Virginia Harrod, noted the policies will have to be approved by the Court. Jailer Stephens asked the Court to approve David Lee Carter, Wesley Morrison, Jeremy S. Raisor, Jonathan B. Roberts and William C. Sanders as new hire part-time jailer transportation officers. Jailer Stephens noted he has requested the background checks, but he has not gotten them back.

Upon motion by Esq. Hawkins and seconded by Esq. Brown, it is ordered by the Court to approve hiring David Lee Carter, Wesley Morrison, Jeremy S. Raisor, Jonathan B. Roberts and William C. Sanders as part-time jailer transportation officers pending satisfactory background checks.
